Attorneys do not provide on-going representation. **No appointment is needed. Walk-ins are seen on a first come, first serve basis and dependent upon the availability of volunteer attorneys.**

Community Law Wednesday Evening Clinic

Every 2nd & 4th Wednesday from 5:00 - 7:00 p.m. Community Law Program sponsors a clinic held at Gulfcoast Legal Services, 641 First St. South, St. Petersburg, where volunteer attorneys provide legal assistance with general civil legal matters.
